

Radnor House School BYOD and WIFI Agreement for Pupils

This agreement must be countersigned by a parent.

Radnor House School is committed to improving the access to learning and the personal development opportunities of its pupils. We believe the use of the electronic devices in class and study can enhance teaching and learning and provide an excellent environment for collaboration and creativity. Please sign below to accept the following terms of use:

1. Electronic devices on school premises are for academic related use only. All users must sign and fully comply with the ICT Acceptable Usage Policy and will observe all usual codes of conduct, policies and safe working practices when using their device as they would using a school PC on site.
2. You acknowledge that the school will administer device management through Microsoft Intune to ensure safeguarding measures are in place. This management will cease upon the pupil's departure from the school.
3. You acknowledge and consent to the installation of Windows 11 Pro Education, which includes a free lifetime upgrade.
4. You consent to the installation of SmoothWall Monitor.
5. By using this device during school hours, you acknowledge and consent to web activity monitoring through SmoothWall Monitor for safeguarding purposes.
6. Pupils may only bring a charged Windows laptop device to school. Smartphones are not included and must remain in lockers.
7. Pupils should only sign in to their device using their school email when on school premises
8. Personal WiFi or mobile broadband (3G,4G and 5G) must be disabled whilst on school premises.
9. Pupils must check their personal ICT device daily for basic Health and Safety compliance to ensure it is free from defects.
10. Anti-virus software must be installed and kept up to date on appropriate devices.
11. Radnor House School takes no responsibility to search for lost or stolen devices nor is there any assumption of financial responsibility by Radnor House School for damaged, lost or stolen personal computing devices.

12. Pupils must make no attempts to circumvent the school's network security. This includes setting up proxies and downloading programs to bypass security.
13. Pupils may use their electronic devices during classroom instruction and library or when otherwise authorised by school personnel provided that the devices are being used for academic purposes only. The corridors and cafe should be electronic device free at all times.
14. The use of a personal ICT device should not to be a distraction in any way to teachers or students. Personal devices must not disrupt class or study areas in any way. Playing games or other non-school work related activities are not permitted.
15. Teachers and classroom staff have the ultimate control of when, how and what type of electronic devices are used in the classroom.
16. In addition to dealing with misuse/disruption within the remit of Radnor House School's Acceptable Use Policy and Behavioral Policy a personal ICT device could be confiscated and kept at reception until parent/guardian picks it up.
